

# Battle Ground Golf Club

Opened on July 4th, 1967, Battle Ground Golf Club resides on 160 acres of property neighboring Prophetstown State Park. The golf course was initially designed by Robert Simmons and was the home of the Lafayette Country Club for nearly 50 years. Two decades ago, the course underwent a considerable renovation under the guidance of Golf Course Architect, Tim Liddy.

Battle Ground is designed to be fair for every golfer, with wide bent grass fairways offering multiple target lines. Sizable greens and large surrounds allow an array of shots to be played from close range. Thick rough and strategically placed bunkers provide protection to the course from the longer hitters. Water comes in to play on three holes only, but requires the full attention of the golfer as they make their way through. The course has 4 sets of tees playing from 5,100 yards in length at the front to almost 7,100 at the back. The property also features a full practice facility that includes a putting green, a short game area, and a driving range equipped with 5 target greens.

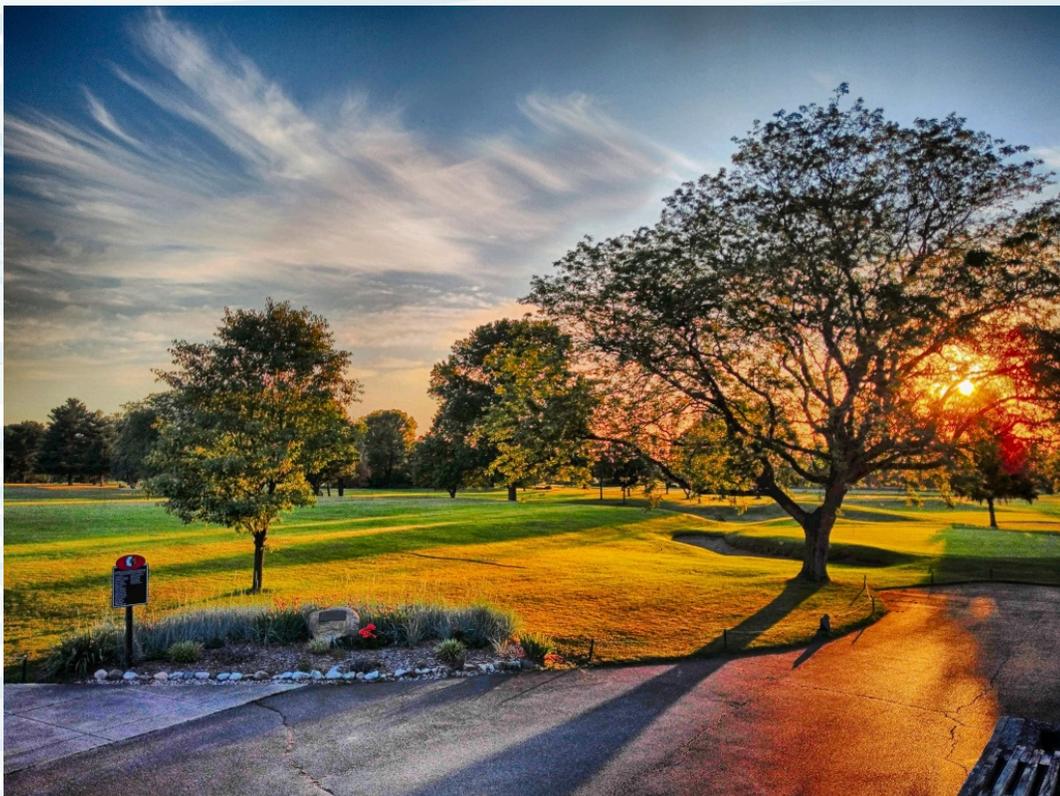

# Golf Outing Contract

## Terms & Conditions

This agreement is made between Battle Ground Golf Club (hereinafter referred to as "BG") and the undersigned (hereinafter referred to as "Group"). Group agrees that the terms of this Agreement are based upon the information in which they provided above. In the event that the information provided by Group materially changes or is incorrect, then this Agreement may be terminated or modified by BG.

PLEASE READ AND INITIAL EACH LINE ACKNOWLEDGING THAT YOU HAVE READ AND UNDERSTAND THE FOLLOWING TERMS AND CONDITIONS

\_\_\_ **PAIRINGS:** In order to adequately prepare for the event, BG requires that pairings be submitted no later than seven days prior to the outing. BG staff will make every attempt to accommodate all pairing changes made on the day of the outing, but last minute changes may not be reflected in the posted pairing information, personalized scorecards, and cart signs. Please provide pairings in excel form to ensure attendee names are spelled correctly.

\_\_\_ **GOLF POLICIES:** Proper golf attire is required which includes non-metal spikes, and no cut-off shirts.

\_\_\_ **EXTRA GOLF CARTS:** If your group requires additional carts there is a minimum order of 14 carts. The fee is \$45 per cart. There is a \$200 Delivery Fee for the rental golf carts. BG has a fleet of 70 golf carts. Please take into account the need for volunteer carts throughout the outing in your total cart count.

\_\_\_ **OUTING MINIMUMS, GOLF COURSE EXCLUSIVITY, and BANQUET EVENT CENTER:** Group is required to pay BG the full guaranteed amount. Group is required to pay all amounts exceeding the guaranteed amount. Guaranteed amount is based on the final headcount given to BG seven (7) days prior to the event. Once inside the window of 7 days, the final headcount number cannot be decreased. If Group has less than 100 players, BG may sell starting times to the membership or general public before or after the start of the event. With the exception of the banquet event center (and any other portion of BG reserved for the outing) BG will remain open to the membership and general public throughout all golf outings. In regards to the use of the Banquet Event Center, please work with Club Manager to secure timeframe needed and extra costs associated with the use of this building.

\_\_\_ **GUARANTEE:** All outings require a final player count seven (7) days prior to the outing. Additions to the guaranteed number will be accepted on a space available basis. Guarantees of attendance are not subject to reduction and BG will charge Group, at a minimum, the amount due in accordance with the guaranteed attendance. If guarantee is not received, the contracted number of guests or revenue minimum will be used as a guarantee.

\_\_\_ **INCLEMENT WEATHER:** Dangerous weather may temporarily suspend play. However, total cancellation of an outing will only occur if BG staff deems the course to be unplayable and unlikely to return to a playable status in a reasonable time to complete the entire outing. BG will make every effort to ensure the outing is played as scheduled. If BG initiates the cancellation of a golf outing due to conditions outlined above, the outing host understands and agrees that the outing fee as outlined within this agreement will still apply. Additionally, should less than 9 holes of golf be completed due to cancellation by BG, rain-check certificates equivalent to the amount of golf not played by each participant will be provided to the outing host.

\_\_\_ **FOOD & BEVERAGE:** We require all food & beverage needs to be met by BG or an approved third-party operator, by a licensed vendor.

\_\_\_ **DEPOSIT:** BG does not require a deposit upon signing of the contract. Final payment of your remaining balance is due fourteen (14) days following your event. If the balance due is not received with fourteen (14) days following your event, BG will charge the remaining balance on the credit card that the outing provided at time of contract signage.

\_\_\_ **CANCELLATION POLICY:** Group agrees that if it cancels this Agreement for any reason, BG will suffer damages. Signature to 119-60 days prior to outing (25% of the total anticipated revenue), and 59 days to the day of the outing (50% of anticipated revenue). Cancellation fee and any related taxes are payable within seven (7) days of the date of cancellation.

\_\_\_ **DAMAGES & LOSSES:** Group shall be responsible for all damages and losses caused to BG employees or property; or to third persons or their property by Group, its guests or invitees. Group assumes all such liability and expense and agrees that, in addition to any other rights as against such guests or others; BG may charge Group's Master Account or directly bill Group for charges.

\_\_\_ **INSURANCE:** Group agrees that it has procured sufficient insurance to cover the loss of all property of Group and its attendees and invitees as well as all liability associated with the event. Group waives any claims under BG's insurance policy for the loss of Group's property or the property of any of its attendees or invitees.

\_\_\_ **INDEMNIFICATION & HOLD HARMLESS:** Group agrees to defend, indemnify, and hold harmless BG, its owner and affiliates, and each of their respective shareholders, directors, officers, employees, agents, and representatives from and against all claims, actions, causes of action, liabilities, costs and expenses, including without limitation reasonable attorneys' fees.

\_\_\_ **OUTSIDE CONTRACTORS:** If Group finds it necessary to use outside services, companies, firms, agencies, individuals, and groups hired by or on behalf of Group shall be subject to prior written approval of BG. If Group uses outside contractors, any such contractor must provide BG with evidence of their commercial general liability insurance policy with limits equal to those required of Group. Group bears responsibility for the payment of any charges incurred at BG by its contractors.

\_\_\_ **ENTIRE AGREEMENT:** This agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes any previous communications, representations or agreements, whether written or oral. Any changes to this Agreement must be made in writing and signed by authorized representative of each party.

\_\_\_ **MISCELLANEOUS:** The person signing this Agreement on behalf of Group warrants that he/she is authorized to bind the Group. Any provision of this Agreement that is deemed unenforceable shall be ineffective to the extent of such unenforceability without invalidating or rendering the remainder of this Agreement invalid.

\_\_\_ **COMPLIANCE WITH LAWS:** Group shall comply with all Federal, State, and local laws, rules and regulations with respect to their activities while on BG property, including obtaining permits required for activities during the outing. BG may require proof of such compliance prior to the outing. BG relies upon Group's attendance projections in reserving the appropriate room(s) and in observing all federal, state and local regulations regarding room capacity limitations and health, safety, and fire codes. BG reserves the right, in its sole discretion, to take any and all actions it deems necessary to cause the outing to be in compliance with all laws, rules and regulations, including without limitation, (1) closing the outing, (2) requiring certain guests leave the outing, (3) restricting access to the outing, (4) restricting the consumption of alcoholic beverages, and (5) monitoring the outing. Such actions of Bg shall be without penalty and Group shall remain liable for all obligations under this Agreement.

\_\_\_ **NO ASSIGNMENT:** Group may not assign or transfer this Agreement or any part thereof without the written consent of BG.

\_\_\_ **RIGHT OF INSPECTION/ENTRY:** BG will have the right to enter and inspect all functions. If BG observes any activity which it determines, in its sole discretion, may be illegal or inappropriate, or that may result in harm to persons or objects, BG has the right to immediately cancel the outing, in which case all of Group's guests and invitees must immediately vacate the premises. In such event, Group will remain liable for all fees and charges related to the function pursuant to the terms of this Agreement.

# Catering

## Terms & Conditions

This agreement is made between Battle Ground Golf Club (hereinafter referred to as "BG") and the undersigned (hereinafter referred to as "Group"). Group agrees that the terms of this Agreement are based upon the information in which they provided above. In the event that the information provided by Group materially changes or is incorrect, then this Agreement may be terminated or modified by BG.

PLEASE READ AND INITIAL EACH LINE ACKNOWLEDGING THAT YOU HAVE READ AND UNDERSTOOD THE FOLLOWING TERMS AND CONDITIONS

### 1. Agreement and Information Accuracy\_\_\_\_\_

The Group agrees that the terms of this Agreement are based upon the information provided by the Group. In the event that the information provided by the Group materially changes or is incorrect, BG reserves the right to terminate or modify this Agreement.

### 2. Menu, Food, and Beverage\_\_\_\_\_

#### 2.1 Menu Confirmation and Changes

The agreed-upon menu of food and beverages is attached hereto as an exhibit. BG reserves the right to make minor, necessary changes to the menu if key ingredients are unavailable due to reasons beyond the control of the Parties.

#### 2.2 Late Changes

Any material changes to the menu requested by the Group less than thirty (30) days prior to the Event date are subject to an additional fee, determined at the sole discretion of BG.

#### 2.3 Leftover Food Policy

In accordance with applicable Health Codes, BG reserves the right to discard any leftover food items after the agreed-upon Event timetable where there is a reasonable risk for foodborne illness to occur. BG assumes no responsibility for the subsequent use of any leftovers by the Group or its guests.

### 3. Fees and Gratuity\_\_\_\_\_

#### 3.1 Service Charge

A 15% service charge will be applied to all events/functions that require wait/server staff. Waitstaff or server staff will only be provided when events are held outside of BG's normal operating hours.

#### 3.2 Catering Fee

All events will be charged a 10% catering fee.

#### 3.3 Event Staff Gratuity

Gratuity for event staff is NOT included in the Group's invoice. Gratuity for BG staff is at the Group's sole discretion and is appreciated. It may be given directly to event service staff at the close of the event or arranged for payment with BG before or after the event.

### 4. Payment Schedule\_\_\_\_\_

#### 4.1 Initial Estimate

Within ten (10) days of receipt of the Group's Catering Information Sheet, BG shall provide an Initial Estimate detailing all anticipated costs and fees for the Event.

#### 4.2 Deposit

The Group must provide a non-refundable deposit equal to 50% of the Initial Estimate to BG on or before thirty (30) days prior to the Event date.

#### 4.3 Final Invoice and Payment

On the day of the Event, BG shall provide the Group with a Final Invoice. The Group shall pay BG the balance of the Final Invoice (less any payments, including the Deposit, previously made) within fourteen (14) days of the Group's receipt thereof.

### 5. Cancellation Policy\_\_\_\_\_

The Group agrees that cancellation of this Agreement will cause BG to suffer damages. The Group will be held financially responsible for a percentage of the Initial Estimate based on the date of cancellation.

#### 5.1 Day Calculation

The day of the event is not counted when determining the notice period. For example, an event scheduled for 04/03/2004 that is canceled on 04/01/2004 is considered canceled two (2) days in advance.

#### 5.2 Cancellation Liability

- More than thirty (30) days prior to the Event: The Group will be responsible for 25% of the Initial Estimate (less any applicable deposits already paid).
- Twenty-nine (29) days prior to the Event: The Group will be responsible for 50% of the Initial Estimate (less any applicable deposits already paid).
- Less than fourteen (14) days prior to the Event: The Group will be billed for the full Initial Estimate (less any applicable deposits already paid).

#### 5.3 Payment Due Date

All payments for cancellation fees are due and payable to BG seven (7) days after the notice of cancellation has been sent to the Group.

### 6. Legal Compliance and Limitation of Remedies\_\_\_\_\_

#### 6.1 Legal Compliance

BG shall operate in compliance with all applicable local health department rules and regulations relating to food preparation and service.

#### 6.2 Limitation of Remedies

If BG (referred to as "Caterer" in this clause) is unable to fulfill its obligations under this Contract for reasons outside of its control, Caterer may either (a) locate and retain a replacement catering company at no additional cost to the Client, or (b) refund the Client's money in full. Caterer will not be responsible for any additional damages or compensation under these circumstances.

### 7. General Provisions\_\_\_\_\_

#### 7.1 Assignment

This Contract cannot be assigned by either Party without the other's express written consent, except as otherwise set forth herein.

#### 7.2 Resolution of Disputes

The Parties agree not to post any negative information about the other arising out of this Contract or Event on any online forum or website without providing advance written notice of the intended content and providing the other Party with an opportunity to resolve any issues amicably.

#### 7.3 Governing Law and Venue

This Contract will be interpreted according to the laws of the State of Indiana. Any legal action must be filed in the County of Tippecanoe in the State of Indiana.

#### 7.4 Entire Agreement

This document, along with its exhibits and attachments, constitutes the entire agreement between the Parties and supersedes all prior agreements, representations, and understandings.
